Ngāti Kahungunu, Rongomaiwahine, Rangitāne o Tamaki nui a Rua

Daphne has been involved in Māori economic development for over 25 years. During that time she established the Kāpiti and Horowhenua Māori economic development agency, the local Māori business network and has represented Māori interests at a national level with Māori business networks, as a member of the Māori Economic Taskforce, the Small Business Advisory Group and Ngā Pū Waea, the Māori telecommunication advisory board.

Daphne has been involved in Māori economic development and Māori business support for over 25 years. During that time she established and continues to lead the Kapiti-Horowhenua Māori Business Network and has represented Māori interests at a national levels in business, education and telecommunications.

Daphne is engaged across Māori health, education, economic development, business and telecommunications. She holds positions with the governing body of Te Wānanga o Raukawa, is the Iwi Co-Chair for the Wellington Regional Skills Leadership Group, and a Director of Wellington NZ.



DR. KATHIE IRWIN - TE MATARAU A MĀUI

Ngāti Kahungunu, Ngāti Porou

Meet Dr. Kathie Irwin, a third-generation educationalist and speaker at the upcoming Tipu Pakihi – Inaugural Māori Business Symposium. Public service and social justice are deeply embedded in Kathie's whakapapa. Her passion inspires her to contribute to nation building, in innovative and creative ways, that are framed by Sir Apirana Ngata's whakatauāki (proverb) "E tipu, e rea". This proverb speaks to the possibilities of Treaty based models of change that create authentic transformation.

As an academic she specialised in Māori education, research and development, for nearly thirty years. Her second career has been in senior management and governance.

In June 2020 she founded Dr. Kathie Irwin and Associates – specialists in education, research and training. She serves as the Founder and CEO.



NAOMI MANU - CO-FOUNDER, AURAKI GROUP LTD

Rangitāne, Ngāti Kahungunu, Ngāti Raukawa

Meet Naomi Manu who is a well-known leader in Māori capability within the science and innovation sector. Naomi founded and established the nationally and internationally award winning Pūhoro STEMM Academy programme. The Pūhoro kaupapa is now embedded which has enabled Naomi to transition from Pūhoro to address workforce development gaps beyond those that the Pūhoro kaupapa is designed to address. Naomi's efforts have helped promote the importance of diversity and inclusion in STEMM and her work is recognised domestically and internationally Naomi is an Obama Foundation Leader for the Asia Pacific region. A strategist, Naomi understands the importance of data-driven solutions and evidence-based decision making.



HONE MCGREGOR - WAKATŪ INCORPORATION

Te Whānau-ā-Apanui, Te Ātiawa, Te Atihaunui-a-Pāpārangi, Ngāti Kahungunu/ Ngāti Kere, Ngāti Raukawa ki te Tonga, Rārua, Rangitāne, Ngāti Kuia

Hone is the Chairman of his whānau's business Wakatū Incorporation , an Māoriowned company of land and sea. Wakatū is one of the leading Māori Incorporations and is based at the top of the South Island - Te Tau Ihu, the 2nd largest landowner and employer of this region (behind the Crown). Wakatū (and its food & beverage company 'Kono' and its health and wellness functional foods company 'AuOra') has embarked on a transformation programme 'Whenua Ora' that has Te Taiao (nature) at its heart, is predicated on sustainable development and is transforming all the Incorporation's business operations from horticulture, viticulture, land development, manufacturing, research and innovation. He is an experienced company director, and chair and board member of several Māori land trusts. He has expertise in corporate management, governance and leadership spanning public, private, NGO/NFP and volunteer sectors; and experience in leading large and complex organisations. Deputy Chair of the Minister for Trade & Export Growth's Ministerial Strategic Advisory Group on Trade (MSAGOT). Hone was also Aotearoa/NZ's first National Director of the United Nation's UNEVOC, a consultant for the Asian Development Bank, former CEO of the Royal Forest & Bird Protection Society of NZ (the first Māori to hold the role) and was CEO of PINZ International consulting company for a decade, working across the Pacific, Middle East and South/SE Asia.

Hone is also currently chair of the Govt's Land & Water National Science Challenge, as well as Chair of VSA - Volunteer Service Abroad (Aotearoa), and Chair of the Ministry of Primary Industries' Fit For a Better World - Te Ao Māori Science Accelerator and his whānau's wetlands restoration trust in Levin. Hone sits on the Executive of the Federation of Māori Authorities (FOMA) and is member of MFAT's Te Taumata Māori Trade Board for international and trade matters. Hone also is a member of the World Economic Forum's Trade & Indigenous Strategic Advisory Committee. He is a former primary school bilingual unit teacher, private fixed-wing pilot, and director of his family farms (Lynvale Farms Ltd, & Te Rāmari Piupiu Roiri Lands trust) and lives in Lyall Bay, Wellington with his partner Rob...and two very spoilt dogs.

Hone has a M.Ed (with Distinction) and a BA in Public Policy and Educational Research from Victoria University of Wellington NZ/Te Herenga Waka.



JARED TUORO - MANA MIND

Te Whakatohea, Te Arawa, Nga Puhi

Jared Tuoro (Aka: JT) at the age of 21 made his debut as a professional rugby player running out onto Eden Park and fulfilling a lifelong dream. Three months later his dream came to an end after suffering a career ending neck injury which triggered years of depression and physical challenges. He then founded Mana Mind - A kaupapa about sharing all the tools and techniques to create a mindset that helped JT get through and overcome set-backs to achieve his dreams and goals of ultimately going on to wear the silver fern, starting his own business and living his dreams by the beach.

Ngāti Raukawa, Ngāti Pareraukawa

My position within the Kaitiakitanga Pūtaiao team is as a Pūkenga Mātua (Lecturer) at the Ōtaki Campus of Te Wānanga o Raukawa.

Caleb Royal, Dr. Mahinaarangi Baker, Tammy Nepata-Gibbs and I make up the kaitiakitanga teaching team. We are supported by Erana Harrison Paurini (Kaikōkiri), and a number of very well qualified and generous kaiawhina who give their time freely to Te Wānanga o Raukawa.

As part of my role here over the years, I have been involved in a number of projects which include research and general taiao restoration projects. One of my main lines of enquiry is through the oral history method of gathering information from elders. We have interviewed and archived dozens of oral history interviews of elders from throughout the Āti Awa, Raukawa, Toa Rangatira (ART) confederation. Our hope is that this material will become valued by future generations and will contribute to better management of our taiao.

I work and live in Ōtaki and consider myself a taxi driver for my four young children - Pareraukawa, Whaiao, Manaakitanga & Rākairoa.



TONI KERR - HEAD OF MĀORI BUSINESS PROJECTS AND STRATEGIC RELATIONSHIPS

Ngāti Tūwharetoa, Ngāti Raukawa ki te Tonga

Toni Kerr, Head of Māori Business Projects and Strategic Relationships at WellingtonNZ. She has over 30 years' experience in banking in Australia, Hong Kong and New Zealand.
